**Referee Assigning**

***Long Discussion.***

Assigning Bureau only made sure referees got paid.  
Did not want to hear about referee discipline.  
Al: Jesus Zornoza snubbed our, (CSSA), President.  
Dan and Kathy Zolad should meet with Jesus.  
Referees are independent contractors.  
State Referee Administrator – Are responsible for discipline.  
Trying to get someone to administer the assignment of Games and referee discipline.  
Some leagues “panicked” and jumped into contracts with Joe Maimone and Gary Walker leaving the rest of the state “high and dry”.  
Ken Brown said I could use those words. (Sic)  
Ken Brown motion reducing player fee to \$20.  
Al: Set up a Committee to do the assigning etc.  
George: CSSA last year was authorized to negotiate collectively, for the State with the SRA Bureau. The leagues the negotiated with the individual assignors abrogated that agreement to detriment of the rest of the leagues.  
Al: Reiterated last years agreement was much better. Agreed with George we should have stayed together.  
Al: Would like to charge the referees.  
Jack: Let's charge them.  
Leigh: What are our options.  
Al: Keep on doing what on you are now. Find out who is paying for phones, website.  
Ken: Recertification charge referees.  
Dave: Recert for those wishing to do adult games.  
Al: The \$5 was not just for assigning.  
Motion: Recind the \$5.00 increase in player fees - 4 , 3 passed.

Jack: The assigning website cost (\$1700) etc be paid by the CSSA.  
Clarified: Provided all leagues are covered.  
Dave: Call the Question.  
Al: Read contract that said it was only for leagues enumerated, CSL etc.
