***Cup Committee:***

Norwalk Manager played himself under another player pass. He had been suspended for a prior red card. Discipline is proscribed in Cup and CSSA playing rules. Long Discussion on when and where suspension will be addressed. Team could not advance in cup.

May use Holidays ( Memorial, Mother's, Father's) as group play dates with July finish for playoffs.

***Rules Committee:***

Dan and George will consolidate rules into one document. 45 day window to submit changes. AGM to be held, March 1<sup>st</sup>. Changes need to in to Secretary by January 16<sup>th</sup>. They will be sent out by February 1<sup>st</sup>. Ken nominated Garfield for VP. Treasurer/Registrar need to be split. Registrar can be added to Secretary. Can add 2<sup>nd</sup> Vice President.

***New Business:***

State Select team is dead. Now Select Player program from USASA.

Prepaid Registrations – SASL will now are having teams cut checks to CSSA, not SASL. 15 players per team. WLSL – Did not pay and we let them pay. This will Resolve several problems. Request procedure form SASL. Discussion followed. Not all leagues may follow this procedure, at this time.
